The CHC50121 Diploma of Early Childhood Education and Care is a nationally recognised qualification from the CHC Community Service Training Package.

### Course Overview

This Course is for professionals who wish to take on a leadership role in an early childhood service and has a strong emphasis on advocacy for the rights of children; the development of strong relationships, effective workplace processes; inclusive, respectful, and responsive workplace culture; and curriculum which focuses on the needs of a child and their individual context.

A Diploma qualification in early childhood provides career opportunities beyond working directly with children, including leadership, management, and support roles. The course covers the following areas:

- Supporting the health, learning and development of children
- Supporting children's learning and development
- Design, planning, implementing, and evaluating educational programs
- Work with families, community, and external agencies
- Providing leadership and support to other staff
- Leadership roles in a variety of early childhood services
- Managing compliance with policies and legislation.

### Formal Entry Requirements

Entry to this qualification is open to individuals who hold either:

- CHC30121 Certificate III in Early Childhood Education and Care; or
- CHC30113 Certificate III in Early Childhood Education and Care.

C&K College is not CRICOS registered and cannot enrol students with a subclass 500 student visa.

### Course Duration

Full time (12 months) or Part time (18 months)

### Delivery Mode

Mixed (online with workshops or webinars plus allocated trainer) with practical placement.

### Intakes

C&K College of Early Childhood is open 50 weeks of the year and takes enrolments at any time.

### Other Requirements

You will need to apply for, and hold a Blue Card (working with children check) for practical placement. You must be fully vaccinated against COVID-19. The COVID-19 Vaccine Mandate is a Queensland Public Health Directive, and as such is lawful and enforceable. C&K College and all other Queensland early childhood education and care training providers must follow this Public Health Directive.

All prospective students must provide proof of full COVID-19 vaccination on enrolment, otherwise their enrolment will not be processed.

You will need access to a computer, the internet, Microsoft Word, Microsoft PowerPoint, PDF Reader software and a scanner or smart phone with camera capabilities.

### Inclusions

All participants receive relevant textbook.

### Apprenticeship

We specialise in finding a training solution which is right for the Trainee, the service, and timeframes (usually 18 to 24 months). Trainees can commence at any time throughout the year. Study options include self-directed study, block or weekly release time and work-based learning and assessment.

### Practical Placement

Participants completing the CHC50121 Diploma in Early Childhood Education and care qualification who do not work in a regulated care service, must complete unpaid vocational placement. This practical component will allow each student to gain experience in a variety of work situations and to put their learning into practice. Participants completing vocational placement will be required to undergo a Working with Children Check and receive a positive notice and blue card.

All assessment is competency based and completion of the placement will be based on competent completion of required tasks, however there is a mandatory requirement for you to complete a minimum number of vocational placement hours for certain units

### Fee Concessions

Fee concessions may apply to government funded courses for eligible students. To be eligible for the concession fee, you must be eligible to access subsidised training (e.g., Certificate 3 Guarantee), as well as meet one of the following criteria:

- hold a valid Health Care or Pensioner Concession Card issued under Commonwealth law
- be named on the card as a partner or dependent of someone holding a valid Concession Card
- be of Aboriginal or Torres Strait Islander descent.

Please note: Proof of eligibility for concession must be demonstrated prior to the commencement of training.

### Payment options

Fees are payable up front or by payment plan (weekly, fortnightly, or monthly payments). C&K staff discounts are available.
