## Diploma of Early Childhood Education and Care

The CHC50113 Diploma of Early Childhood Education and Care is a nationally recognised qualification from the CHC Community Services Training Package.

### Start a new career and take on a leadership role

It's a great time to start a career in early childhood. The sector is expanding and those with the right qualifications are in demand. This is a career where you can make a difference and be a positive influence in shaping young lives.

Early childhood education and care qualifications prepare students for employment in regulated care services such as child care, long day care, kindergartens, occasional care and family day care. It is also a popular qualification for those working as nannies, children's programs and running playgroups.

With a qualification in early childhood, you can work in different early childhood settings – from community-based or not-for-profit services to privately-owned organisations, and/or to services located on school grounds. You can also provide family day care from your own home.

The Diploma of Early Childhood Education and Care is for people who wish to take on a leadership role in an early childhood service and has a strong emphasis on advocacy for the rights of children; the development of strong relationships, effective workplace processes; inclusive, respectful and responsive workplace culture; and curriculum which focuses on the needs of a child and their individual context.

A Diploma qualification in early childhood provides career opportunities beyond working directly with children, including leadership, management and support roles.

When you hold a diploma, you can do further study to become an early childhood teacher and you may be given credit for subjects you have already completed.

The C&K College of Early Childhood also offers the Early Childhood Teacher Bridging Program. This course is a tailored, 'fast-track' pathway to a diploma qualification that enables registered primary teachers to work as early childhood teachers.

### Becoming a Diploma Educator

**You need to:** hold or be studying towards an approved diploma qualification to work in a regulated care service.

**Study time:** 12 to 18 months full-time. Students studying part-time may take up to 3 years.

**Vocational placement:** students completing a Diploma qualification who do not work in a regulated care service, must complete unpaid vocational placement. This practical component will allow each student to gain experience in a variety of work situations and to put their learning into practice. Students participating in vocational placement will be required to undergo a Working with Children Check and receive a positive notice and blue card.

All assessment is competency based and completion of the placement will be based on competent completion of required tasks, however there is a mandatory requirement for you to complete a minimum number of hours for certain units. This includes:

- CHCECE007 Develop positive and respectful relationships with children - 120 hours
- CHCECE003 Provide care for children - 120 hours
- CHCECE005 Provide care for babies and toddlers - 120 hours
- CHCECE019 Facilitate compliance in an education and care services - 120 hours

- CHCECE017 Foster the holistic development and wellbeing of the child in early childhood - 240 hours
- CHCECE024 Design and implement the curriculum to foster children's learning and development - 240 hours

The hours listed may be completed concurrently. For example, you may be working with a group of 3-5 year olds and developing positive and respectful relationships with children (CHCECE007) while you are providing care for children (CHCECE003) and supporting their development (CHCECE017). This would mean the one hour of work can contribute to the hours required for three units.

Early childhood teaching students are able to be counted as diploma level educators for ratio purposes while they are 'actively working towards' an approved early childhood teaching qualification. The Education and Care Services National Regulations state under Section 126: Centre based services - The qualification requirements for educators at centre-based services for children preschool age or under are - at least 50 per cent of the educators who are required to meet the relevant educator to child ratios for the service must have, or be actively working towards, at least an approved Diploma level education and care qualification.

## Why study with the C&K College of Early Childhood?

A vocational placement supervisor helps to develop a student by:

- Monitoring and signing off on the daily attendance
- Observing specific assessment tasks and providing advice and guidance
- Completing a workplace observation checklist
- Providing service resources and information (e.g. policy and procedures)

C&K course incorporates a number of Early Childhood Education and Care (ECEC) professional development (PD) activities. These PD activities will deliver a deeper understanding of what it means to be an early childhood professional, along with a greater appreciation of the implications and impacts of your work. The assessment process will confirm you have absorbed the necessary skills and your capability to apply them correctly in your work.

## Study pathways

C&K College of Early Childhood offers adaptable courses that respond to the latest industry developments and are linked to real employment opportunities.

We offer guaranteed vocational placement and provide a link to employment opportunities, with graduates eligible to apply for a position with the Crèche and Kindergarten Association. Or students may arrange their own vocational placement in an organisation of their choice. All assessment is competency based and completion of the placement will be based on competent completion of required tasks, however there is a mandatory requirement for you to complete a minimum number of hours for certain units.

## Delivery Options

The College offers multiple delivery options for our courses, so you may choose to study in a way that suits your lifestyle. Students may study on a full-time or part-time basis.

Flexible learning means you may study through distance learning. If you prefer the campus experience, you may study in a classroom environment at our training campus at Kedron or anywhere a structured program is running.

If you're not sure what's right for you, give us a call. We're happy to talk you through the options and help you make the best choice to suit your individual situation.

**Blended learning:** blended learning with flexible study options (self-directed study, phone tutoring, students can opt in and out of classes, vocational placement and work-based assessment) 18 to 36 months ...the more time allocated to study will determine when a qualification is achieved.

**Apprenticeship:** as per the training contract (self-directed study, block release time and/or appropriate structured work-based learning and assessment) – we specialise in finding a training solution which is right for the Trainee, the service and timeframes (usually 18 to 24 months).

## Intakes

C&K College of Early Childhood has four major intakes in January, April, July and October. If you are interested in starting a qualification outside of these times, please call Helpdesk on 07 3513 2524 to discuss.

Apprentices are able to commence at any time throughout the year.

## Recognition of Prior Learning (RPL)

If you have current Early Childhood sector skills and experience, but not a formal qualification, you may be eligible for Recognition of Prior Learning (RPL). The C&K College of Early Childhood recognises prior experience and learning. Students work through a toolkit which allows them to demonstrate their knowledge and skills without completing additional learning. Students can work through the toolkit at their own pace and are assessed on skills and knowledge through the Recognition process. ## Credit Transfer and First Aid

The C&K College of Early Childhood does not offer the First Aid competency standard, at this time. Students will need to undertake the required First Aid course (HLTAID004 Provide an emergency first aid response in an education and care setting) and provide a copy of the Statement of Attainment to the College for the Credit Transfer process.

Should the College engage a specialist first aid trainer, students will be advised of the cost of attending the first aid course prior to enrolment in the unit and attendance at training workshop.

## Full fee paying students

The full cost of the diploma program is **\$9,180 (\$340 per unit)**.

## Funding options

To assist with studying funding may be available to eligible students:

### User Choice Funding: Apprenticeship Program

The C&K College of Early Childhood provides training for Apprentice study pathway for learners who have secured employment within an approved Early Childhood Education and Care service. Eligible apprentices and trainees that meet the Queensland state funding requirements will be charged a set fee per nominal hour. These fees are calculated at a regulated rate of **\$1.60 per nominal hour**. Concession rates apply for students who hold a current Health Care Card or who identify as Aboriginal or Torres Strait Islander.

### Higher Level Skills Program

The *Higher Level Skills Program* is for any Queensland resident who does not already hold, or is not already enrolled in, a post-school Australian certificate IV or higher level qualification this includes any equivalent certificate IV or higher level qualification irrespective of whether the qualification is through a university degree, apprenticeship or traineeship pathway.

**Cost to participant:** a student co-contribution fee of \$140 per unit, or \$93 per unit for concessional students is required. The full cost of the diploma is **\$3,780 (or \$2,511 concessional students)**.

### C&K and C&K Affiliate staff discount

- C&K supports staff undertaking a Traineeship through structured on-the-job and off-the-job paid training and there are no additional training course fees when studying with the C&K College. Please refer to C&K Careers.
- Employees (full-time and part-time) who enrol in a Diploma of Early Childhood Education and Care, outside of a Traineeship pathway, may be eligible for DET subsidised training and receive a staff discount. The discount cost of the diploma course is \$1,080 (or \$270 for concessional students).
- Where staff are not eligible for DET subsidised training, C&K and C&K Affiliate staff may undertake individual units at the reduced cost of \$250 per unit (full-time and part-time staff).
- C&K employees may also seek financial assistance with the cost of the course under the C&K Education Assistance Policy and/or apply for VET Student Loan.

### VET Student Loans

From 1 January 2017, a new VET Student Loans (VSL) program was implemented by the Australian Department of Education and Training to give eligible students access to quality higher level VET qualifications, particularly those students who could not otherwise afford to pay upfront.

Students enrolling in the Diploma course through the C&K College of Early Childhood (RTO no 5025) may be eligible to apply for the Australian Government's Vet Student Loans program. Please read the *VET Student Loans information booklet* for more information.

Please note:

- Students must have read the VET Student Loans Information Booklet when applying for a VET Student Loan
- C&K College of Early Childhood will not approve a VET student loans for students who do not meet the eligibility requirements
- A VET student loan gives rise to a HELP debt that continues to be a debt due to the Commonwealth until it is repaid
- The VET Student Loans program is a loan given to eligible fee-paying students to help pay for part, or all, of their tuition fees The maximum tuition fee for the C&K Diploma course is **\$9,180**. Students who are eligible for subsidised training through the DET Higher Level Skills program may apply for a VET Student Loan to help pay the student **co-contribution fee**. Please refer to the Diploma of Early Childhood Education and Care Cost schedule at the end of the 2018 Student Guide as the maximum cost will vary between **\$270 and \$3,780** depending on your situation and funding eligibility rules.

To be eligible for a VET Student Loan you must demonstrate competence at, or above **Exit Level 3** (working in Level 4) in the Australian Core Skills Framework (ACSF) in both reading and numeracy.

You can demonstrate your reading and numeracy competence in one the following ways:

- Supply a copy of your Year 12 Certificate of Education awarded to you by the board of studies of an Australian State or Territory. It does not matter when you completed high school.
- Supply a copy of your Australian Qualification Framework (AQF) Level IV or higher qualification that was taught in English in 1995 or after.
- Complete a **bksb skills assessment** and achieve an Exit Level 3 (working in Level 4).

## Pathway to university

When you hold a diploma, you can do further study to become an early childhood teacher.

The C&K College of Early Childhood has a number of articulation arrangements in place, including:

- Australian Catholic University – for the Bachelor of Education (Birth to Five years) at any location/jurisdiction students will be eligible for 80cp (for specified credit) and for the Bachelor of Education (Early Childhood and Primary) at any location/jurisdiction students will be eligible for 30cp to 60cp (for specified credit depending on strand)
- CQ University - nine exemptions into CQ University's Bachelor of Education (Early Childhood) CC14 or the Bachelor of Education (Primary) CC12.
- Griffith University – 80CP credit transfer towards the Bachelor of Child and Family Studies 1095 (4 semester, 3 year degree), Logan campus, for completion of the Diploma of Early Childhood Education and Care (CHC50113)

The C&K College of Early Childhood have established a relationship with the Deakin Institute of Koorie Education and students who have successfully met the literacy and numeracy standards of the university have been able to enrol into the degree and receive one year of credit for prior learning.
